Sub.-: Renewal of permission for MBBS course for 2nd batch (100 seats) of Govt. Medical College & Hospital, Balasore, Odisha (renamed as Fakir Mohan Medical College & Hospital, Balasore) under Fakir Mohan University, Balasore, Odisha u/s 10A of the IMC Act, 1956 for the academic year 2019-20.

Sir/Madam,

I am directed to convey the approval of Board of Governors in supersession of Medical Council of India for renewal of permission for admission of 2nd batch of 100 (Hundred only) MBBS students at Government Medical College & Hospital, Balasore, Odisha (renamed as Fakir Mohan Medical College & Hospital, Balasore) u/s 10A of the IMC Act, 1956 for the academic Year 2019-2020.

2. The Board of Governors has granted approval after consideration of the Compliance Verification Assessment Report (8th April, 2019) alongwith the summary/observations of the member of the Undergraduate Expert Group appointed by the Board of Governors and an undertaking of the Secretary, Health & F.W. Department, Government of Odisha dated 28.05.2019.

3. The Permission is valid for one year and for admitting only one batch of 100 students during the academic year 2019-2020. The next batch of students in MBBS course will be admitted in the college only after permission of Board of Governors in supersession of the MCI for renewal/recognition.

4. The Government Medical Colleges (except those located in J & K States) shall contribute 15% of MBBS seats for which the renewal permission is granted for all India quota.

5. Admissions made in violation of the above condition will be treated as irregular and action will be initiated under IMC Act & Regulations made there under.

6. Discrepancies, if any, may be immediately brought to the notice of the Board of Governors in supersession of the MCI and the State Govt.
