Objective:

This institution has a strict policy to provide protection against sexual harassment of women and redressal of complaints in the time bound manner under the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act & the Rules, 2013. Any person found guilty shall face severe penal consequences under this act.

Penalty for Sexual Harassment:

Internal Complaint Committee (ICC) arrives at the conclusion that the allegation against the respondent has been proved. It shall recommend to the employer to take following actions as stipulated in *sec.-13*:

- Sexual harassment will be treated as misconduct in accordance with the provisions of the service rules applicable to the respondent.
- Deduct from the salary or wages of the respondent such sum as it may consider appropriate to be paid to the complainant or to her legal heirs. ICC shall determine compensation with regard to sec.-15:
 - The mental trauma, pain, suffering and emotional distress;
 - The loss in the career opportunity due to the incident;
 - Medical expenses for physical or psychiatric treatment;
 - The income and financial status of the respondent;
 - Feasibility of such payment in lump sum or ininstallments.
