**ADVERTISEMENT FOR FILLING UP OF POSTS OF PROFESSOR/ ASSOCIATE PROFESSOR IN  
FM MCH, BALASORE ON CONTRACTUAL BASIS.**

In pursuance of Notification No.1532/H dtd.19.01.2024 read with Resolution No.8967/H dtd.25.04.2022 of Health & F. W. Department, Govt. of Odisha, eligible candidates are invited to attend the Walk in Interview for the post of Professor / Associate Professors in Fakir Mohan Medical College & Hospital, Balasore on contractual basis in view of NMC urgency. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years. The details of eligibility criteria/ vacancies/ etc are as under

**1. VACANCY & PROGRAMME:**

The vacancy is provisional and is subject to change as on the date of Walk-in-Interview/counseling. Vacancies occurring after the date of counseling shall be filled up through fresh advertisement. The detailed vacancy attached in Annexure-II and the tentative programme will be available in the website of FMMCH, Balasore (i.e. <https://www.blsmch.nic.in>).

**2. ELIGIBILITY:**

2.1 The candidate must be a citizen of India.

2.2 Qualification:

**2.2.1 ASSOCIATE PROFESSOR**

2.2.1.1 Must have possessed MD/MS/DNB or equivalent degree in the concerned specialty. In case of non availability of candidates in Anatomy, Physiology & Biochemistry the candidates with medical M.Sc. qualification with Ph. D may be considered or as per Teachers Eligibility Qualifications (TEQ, 2022) of NMC and its amendment and OMES rule 2021.

2.2.1.2 Must have teaching experience of minimum 4 years as Assistant Professor in the concerned discipline in any MCI/ NMC permitted / recognized institute with research publications as per MCI/NMC guidelines / OMES Rule 2021 in force.

- 2.2.1.3 Must have valid up to date medical registration along with registration of additional qualification under any State Council of Medical/ Dental Registration after obtaining the degree.
- 2.2.1.4 Must have completed basic course in medical education from institution designated by NMC.
- 2.2.1.5 Must have completed basic course in Bio-Medical Research.

**2.2.2 PROFESSOR:**

- 2.2.2.1 Must have possessed MD/MS/DNB or equivalent degree in the concerned specialty.
- 2.2.2.2 In case of non-availability of candidates in Anatomy, Physiology & Biochemistry the candidates with medical M.Sc. qualification with Ph. D may be considered or as per Teachers Eligibility Qualifications (TEQ, 2022) of NMC and its amendment and OMES rule 2021.
- 2.2.2.3 Must have teaching experience of minimum 3 years as Associate Professor in the concerned discipline in any MCI/ NMC permitted/ recognized institute with research publications as per MCI / NMC guidelines/ OMES Rule 2021 in force.
- 2.2.2.4 Must have any other qualification as may be prescribed by NMC.
- 2.2.2.5 Must have valid up to date medical registration along with registration of additional qualification under any State Council of Medical Registration after obtaining the degree.
- 2.2.2.6 Must have completed basic course in medical education from institution designated by NMC.
- 2.2.2.7 Must have completed basic course in Bio-Medical Research.

**3. AGE LIMIT**

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 years).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/ Council only shall be accepted.



#### 4. PROCEDURE OF APPLICATION

Interested candidates shall download the Application Form annexed in this Advertisement from the official website of FM MCH, Balasore (i.e. <https://www.blsmch.nic.in>).

The candidate shall have to appear in person before the Convenor, Selection Committee in the Office of Dean & Principal, FM MCH, Balasore as per schedule and submit the application form attached to this advertisement duly filled in and photocopy of required documents and color passport photograph. They must bring the original documents for verification without which the candidature will be invalid. After successful verification of the documents a merit list shall be prepared and notified on the spot. Any other information shall be notified by the Convener in the website of FM MCH, Balasore (i.e. <https://www.blsmch.nic.in>).

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

#### 5. PROCEDURE OF SELECTION

- a. Selection will be strictly on the basis of merit list prepared on basis of teaching experience, research publications and age of the candidate:-
  - i. Weightage for teaching experience: 5 marks per year of experience as Asst. Professor/ Assoc. Professor from MCI/NMC/ permitted or recognized institutions.
  - ii. Weightage for research publications: 5 marks per publication; (publication as per norm of NMC shall be considered).
- b. In case of tie, it will be resolved as follows:
  - i. In case of tie the elderly, candidates shall be placed higher in rank to the younger."
- c. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- d. In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- e. All communication shall be made through the website of FM MCH, Balasore (i.e. <https://www.blsmch.nic.in>). No Postal/ personal communication will be made.
- f. Engagement will be on the basis of merit and choice. Appointment/ Engagement order shall be uploaded in the website of FM MCH, Balasore (i.e. <https://www.blsmch.nic.in>). The candidates must report before the authority of this institution with immediate effect of issue of engagement order or as may be instructed in the appointment order.

## **6. TERMS AND CONDITIONS**

All the terms and conditions as per Govt. letter issued from time to time shall be applicable.

- a. The Contractual Professors are entitled for remuneration of Rs. 2,30,000/- per month. The Contractual Associate Professors are entitled for remuneration of Rs. 2,00,000/- per month. In addition to the above, any incentive as may be notified by the Govt. shall be allowed.
- b. The engagement shall be purely temporary and on year-to-year tenure basis and may be for a period of maximum four years subject to satisfactory performance or till the appointment made on regular basis whichever is earlier. However, the Govt. reserves the right to terminate the services of the faculty with one month prior notice without assigning any reason.
- c. All the communications shall be made through the website of FM MCH, Balasore (i.e. <https://www.blsmch.nic.in>) and no personal communication shall be made.
- d. Selected candidates have to sign an agreement as per Govt. resolution 8967/H&FW Dt. 25.4.2022 at the time of Joining.
- e. In case the candidate appointed to a post fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- f. The faculties whose tenure is terminated for any reason by the appointing authority, will be debarred from being selected for a period of next three years.
- g. All other terms & conditions shall be followed as per the Resolution No.8967/H dtd.25.04.2022 of Health & F.W Department.



- ii. H.S.C./ Equivalent Certificate in support of age;
- iii. +2/ Equivalent Examination Certificate;
- iv. MBBS/ MD/MS/DNB/ MSc with PhD Pass Certificate;
- v. Mark sheets in support of all the aforesaid examinations (i.e. from H.S.C. onwards) passed including fail marks if any.
- vi. Certificate of Registration for Medical Qualifications from Odisha Council of Medical Registration (valid up to date for UG & PG);
- vii. Chance Certificate of MBBS/ MD/MS/DNB/ MSc is mandatory.



- viii. Teaching Experience certificate from Competent Authority.
- ix. No Objection Certificate from Non Odisha Govt. Employer/Authority
- x. Photo ID issued by the Govt. authorities i.e. Passport/PAN Card/VoterI card/, AADHAAR card
- xi. If a candidate claims to possess qualification equivalent to the prescribed qualification, the rule/ authority (with number and date) under which it is so treated must be furnished with the application form.
