**ADVERTISEMENT FOR FILLING UP OF POSTS OF PROFESSOR/ ASSOCIATE PROFESSOR IN
FM MCH, BALASORE**

In pursuance of Notification No.1532/H dtd.19.01.2024, corrigendum No. 4966/H dt.26.02.2024 & Letter No. 12664/H dtd.14.05.2024 of Health & F. W. Department and letter No. 3447 dtd.06.03.2024 of DMET(O), Bhubaneswar read with Resolution No.8967/H dtd. 25.04.2022 of Health & F. W. Department, Govt. of Odisha, eligible candidates are invited to attend the Walk-in-Interview for the post of Professor / Associate Professors in Fakir Mohan Medical College & Hospital, Balasore on contractual basis in view of NMC urgency. The regular faculties (under OMES cadre) of any Govt. Medical College of the state, VIMSAR, Burla or AHRCC Cuttack are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years. The details of eligibility criteria/ vacancies/ etc are as under

1. VACANCY & PROGRAMME:

The vacancy is provisional and is subject to change as on the date of Walk-in-Interview/counseling. Vacancies occurring after the date of counseling shall be filled up through fresh advertisement. The detailed vacancy attached in Annexure-II will be available in the website of FMMCH, Balasore (i.e. <https://www.blsmch.nic.in>).

2. ELIGIBILITY:

2.1 The candidate must be a citizen of India.

2.2 Qualification:

2.2.1 ASSOCIATE PROFESSOR

2.2.1.1 Must have possessed MD/MS/DNB or equivalent degree in the concerned specialty. In case of non availability of candidates in Anatomy, Physiology & Biochemistry the candidates with medical M.Sc. qualification with Ph. D may be considered or as per Teachers Eligibility Qualifications (TEQ, 2022) of NMC and its amendment and OMES rule 2021.

- 2.2.1.2 Must have teaching experience of minimum 4 years as Assistant Professor in the concerned discipline in any MCI/ NMC permitted / recognized institute with research publications as per MCI/NMC guidelines / OMES rule 2021 in force.
- 2.2.1.3 Must have valid up to date medical registration along with registration of additional qualification under any State Council of Medical/ Dental Registration after obtaining the degree.
- 2.2.1.4 Must have completed basic course in medical education from institution designated by NMC.
- 2.2.1.5 Must have completed basic course in Bio-Medical Research.

2.2.2 PROFESSOR:

- 2.2.2.1 Must have possessed MD/MS/DNB or equivalent degree in the concerned specialty.
- 2.2.2.2 In case of non-availability of candidates in Anatomy, Physiology & Biochemistry the candidates with medical M.Sc. qualification with Ph. D may be considered or as per Teachers Eligibility Qualifications (TEQ, 2022) of NMC and its amendment and OMES rule 2021.
- 2.2.2.3 Must have teaching experience of minimum 3 years as Associate Professor in the concerned discipline permitted/ recognized institute in any MCI/ NMC as the case may be with research publications as per MCI / NMC guidelines/ OMES Rule-2021 in force.
- 2.2.2.4 Must have valid up to date medical registration along with registration of additional qualification under any State Council of Medical Registration after obtaining the degree.
- 2.2.2.5 Must have completed basic course in medical education from institution designated by NMC.
- 2.2.2.6 Must have completed basic course in Bio-Medical Research.
- 2.2.2.7 All qualification as on date of walk in interview shall be considered.

3. AGE LIMIT

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

4. PROCEDURE OF APPLICATION

- i. Interested candidates shall download the Application Form annexed in this Advertisement from the official website of FM MCH, Balasore (i.e. <https://www.blsmch.nic.in>).
- ii. The candidate shall have to appear in person before the Convenor, Selection Committee in the **Office of Dean & Principal, FM MCH, Balasore** as per schedule and submit the application form attached to this advertisement duly filled in and photocopy of required documents and color passport photograph. They must bring the original documents for verification without which the candidature will be invalid.
- iii. After completion of Document Verification & Selection Procedure, a Provisional Merit List shall be prepared and notified in the website (www.blsmch.nic.in) on 14.11.2024 for inviting any grievance to the merit.
- iv. The grievances from the candidates, if any, will be allowed to be put forth to the Email 'dean.fmmchb@gmail.com' by 14.11.2024.
- v. The Final Merit List will be notified and Engagement Order will be uploaded in the website after compilation of grievance if any.
- vi. The date & timing of publication of provisional & final merit list may be changed depending upon the number of candidates attending walk in interview.

N.B.: In case any candidate is found to have provided a false information or certificate or to have withheld or concealed any information on the date of interview or later, his/her application shall be rejected and/ or disciplinary /legal action as deemed proper will be initiated against him/her. At the time of document verification / counseling / choice filling physical presence of the candidate is mandatory and no authorization will be entertained.

5. PROCEDURE OF SELECTION

- a. Selection will be strictly on the basis of merit list prepared on basis of teaching experience, research publications and age of the candidate:-
 - i. Weightage for teaching experience: 5 marks per year of experience as Asst. Professor/ Assoc. Professor from MCI/NMC/ DCI permitted or recognized institutions.
 - ii. Weightage for research publications: 5 marks per publication; (publication as per norm of NMC shall be considered).

- b. In case of tie, it will be resolved as follows:
 - i. In case of tie the elderly, candidates shall be placed higher in rank to the younger.”
- c. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.
- d. In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- e. All communication shall be made through the website of FM MCH, Balasore (i.e. <https://www.blsmch.nic.in>). No Postal/ personal communication will be made.
- f. Engagement will be on the basis of merit and choice. Appointment/ Engagement order shall be uploaded in the website of FM MCH, Balasore (i.e. <https://www.blsmch.nic.in>). The direct candidates must report before the authority of this institution within seven days of issue of engagement order or as may be instructed in the appointment order and the in-service candidates shall join after obtaining the relieve order from Government.

6. TERMS AND CONDITIONS

All the terms and conditions as per Govt. letter issued from time to time shall be applicable.


- a. The Contractual Professors are entitled for remuneration of Rs. 2,30,000/- per month. The Contractual Associate Professors are entitled for remuneration of Rs. 2,00,000/- per month. In addition to the above, any incentive as may be notified by the Govt. shall be allowed.
- b. The in-service candidates shall be allowed salary at par to the post in which appointed and any incentive as may be notified by Govt. It will be guided as per the Govt. letter No. 9684/H Dt 02.05.2022 or as may be notified by the Govt. from time to time.
- c. The engagement shall be purely temporary and on year-to-year tenure basis and may be for a period of maximum four years subject to satisfactory performance. However, the Govt. reserves the right to terminate the services of the faculty with one month prior notice without assigning any reason.
- d. All the communications shall be made through the website of FM MCH, Balasore (i.e. <https://www.blsmch.nic.in>) and no personal communication shall be made.
- e. Selected candidates have to sign an agreement as per Govt. resolution 8967/H&FW Dt. 25.4.2022 at the time of Joining.
- f. In case the candidate is offered engagement and fails to join within seven days from the date of publication in the website, then the offer shall stand forfeited and next candidate in the merit list of the subject may be given the offer.
- g. The faculties whose tenure is terminated for any reason by the appointing authority, will be debarred from being selected for a period of next three years.
- h. All other terms & conditions shall be followed as per the Resolution No.8967/H dtd.25.04.2022 of Health & F.W Department.

- viii. Teaching Experience certificate from Competent Authority.
- ix. No Objection Certificate from Non Odisha Govt. Employer/Authority
- x. Photo ID issued by the Govt. authorities i.e. Passport/PAN Card/Voter ID card/, AADHAAR card
- xi. If a candidate claims to possess qualification equivalent to the prescribed qualification, the rule/ authority (with number and date) under which it is so treated must be furnished with the application form.
