ADVERTISEMENT FOR FILLING UP OF POSTS OF JUNIOR RESIDENT IN FM MCH, BALASORE

In pursuance of Notification No.1532/H dtd.19.01.2024, corrigendum No. 4966/H dt.26.02.2024 & Letter No. 12664/H dtd.14.05.2024 of Health & F. W. Department and letter No. 3447 dtd.06.03.2024 of DMET(O), Bhubaneswar read with Resolution No.18582/H dtd.13.08.2020 of Health & F. W. Department, Govt. of Odisha, eligible candidates are invited for Walk-In Interview for Selection to the Posts of Junior Resident in FM MCH, Balasore on contractual basis. The applicant must have acquired the required qualification for the post applied for, on or before the date of Walk-in-Interview. The engagement shall be purely temporary for a period of one year which may be extended on year-to-year basis. The posts are non-practicing. The candidates will be paid consolidated amount of Rs.60,000/- (Rupees Sixty thousand only) per month. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable. Eligibility of application will be guided as per the provisions mentioned here under:

1. Vacancy: 26 Posts

N.B: The vacancy is provisional and is subject to change as on the date of Walk-in-Interview. Vacancies occurring after the date of Walk-in-Interview shall be filled up through fresh advertisement.

2. Schedule of Walk-in -Interview:

Date: 15.04.2025

Reporting Time: 10.30 AM to 11.30 AM

Venue: Office of Dean & Principal, FM MCH, Balasore

- 3. Age: Must be less than 69 years.
- 4. Eligibility and Qualifications for Junior Residents:
 - i. Qualification:
 - i. A candidate must possess a MBBS degree (for medical stream) or equivalent degree recognized by MCI/NMC as the case may be.
 - ii. The candidate must have completed the compulsory one-year rotating internship.
 - The above qualifications must have been obtained on or before the date of counseling.

ii. Other Eligibility Conditions:

- i. The candidate must be a citizen of India.
- ii. The candidates must have registered their Medical Qualification at Central/ State Medical Council. (Permanent Registration)
- iii. Candidates having post-graduation in any discipline or are continuing or have completed the three years tenure as Senior Resident / Tutor in any MCI /NMC permitted /approved/ recognized institute are not eligible to apply.
- Candidates who are serving under OMHS cadre on regular basis are not eligible to apply.

5. Procedure for Application:

Candidates shall download the Application Form (i.e Annexure-A) enclosed in this Advertisement from the Official website of FM MCH, Balasore (https://www.blsmch.nic.in) and come for the Walk in Interview along with duly filled in Application Form and all requisite documents (in original and its photocopy).

6. Procedure of Interview:

- a. The candidate shall have to appear in person before the Convenor, Selection Committee on the schedule date & venue along with the following documents:
 - 1. Application Form Duly filled in
 - 2. One recent passport size colour photograph signed by the candidate at front to be pasted on the application form.
 - 3. All Original Documents and Self-attested Photocopies of
 - i. H.S.C. / Equivalent Certificate,
 - ii. +2 Science / Equivalent Examination Certificate;
 - iii. MBBS Pass Certificate
 - iv. Mark Sheets in support of all the aforesaid examinations
 - v. Chance Certificate
 - vi. Internship Completion Certificate
 - vii. Certificate of Medical Registration (valid)
 - viii. Valid Photo ID Card issued by Govt. Authority (Passport/ Aadhaar Card/ PAN Card/ Voter ID Card)
- b. There will be Document Verification and Interview by the Selection Committee based upon which candidates will be selected. At the time of document verification, physical presence of the candidate is mandatory and no authorization will be entertained.

7. Selection of Candidates:

- i. After completion of Document Verification & Selection Procedure, a Provisional Merit List shall be prepared and notified in the website (www.blsmch.nic.in) on 16.04.2025 for inviting any grievance to the merit.
- ii. The grievances from the candidates, if any, will be allowed to be put forth to the Email 'dean.fmmchb@gmail.com' by 17.04.2025.
- iii. The Final Merit List will be notified and Engagement Order will be uploaded in the website after compilation of grievance if any.
- iv. The candidates must report before the head of Office immediately or within 7 days of issue of engagement order.
- v. In case the candidate does not join, the next candidate in the Merit list will be allowed to join in the same post.
- vi. The final merit list will remain valid for a period of one year or till subsequent advertisement whichever is earlier. Any other related information / changes if required shall be notified by the Convener, Selection Committee in the official website of FMMCH, Balasore i.e. https://www.blsmch.nic.in. All communication shall be made through the website of FMMCH, Balasore (No Postal/ Personal communication will be made).
- vii. The date & timing of publication of provisional & final merit list may be changed depending upon the number of candidates attending walk in interview.

N.B.: In case any candidate is found to have provided a false information or certificate or to have withheld or concealed any information on the date of interview or later, his/her application shall be rejected and/or disciplinary /legal action as deemed proper will be initiated against him/her.

8. Selection Process:

1. Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:

HSC/Matriculation- 20% of total percentage of marks secured. Intermediate Science- 20% of total percentage of marks secured. MBBS examination- 60% of total percentage of marks secured.

- 2. One mark will be deducted from total Career Mark for each extra attempt taken to pass the examination.
- In case of Foreign Medical Graduates (FMGE), the marks secured in the subjects as per the NMC/MCI conducted by NBE shall be taken for calculation of merit as above. Where the candidate does not submit such mark sheet, their mark shall be taken as 50%.
- 4. In case of tie, it will be resolved as follows:
 - i. The candidate securing more mark in MBBS shall be placed in higher rank.
 - ii. In case of further tie, the elderly candidates shall be placed higher in rank to the younger."

9. Terms and Conditions:

The terms and conditions will be followed as per the Resolution No.18582/H dtd.13.08.2020 of Health & F. W. Department, Govt. of Odisha and Govt. Guidelines issued from time to time in force.
