**ADVERTISEMENT FOR FILLING UP OF POSTS OF SENIOR RESIDENTS / TUTORS IN
FM MCH, BALASORE**

In pursuance of Notification No.1532/H dtd.19.01.2024, corrigendum No. 4966/H dt.26.02.2024 & Letter No. 12664/H dtd.14.05.2024 of Health & F. W. Department and letter No. 3447 dtd.06.03.2024 of DMET(O), Bhubaneswar read with Resolution No.18582/H dtd.13.08.2020 of Health & F. W. Department, Govt. of Odisha, eligible candidates are invited for **walk-in interview** for selection of the posts of Senior Residents (SR), Tutors in different disciplines in FM MCH, Balasore. The applicant must have acquired the required qualification for the post applied for on or before the date of walk-in interview. The engagement shall be purely temporary for a period of one year which may be extended on year to year basis for maximum period of 3 years on satisfactory performance. The posts are non-practicing. The in-service candidates will be entitled to draw their usual salary and the direct candidates will be paid consolidated amount as notified by Govt. from time to time. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable. The candidates who are continuing as post PG bond service are entitled for teaching experience certificate as SR for two years and **hence shall not apply**. Eligibility of application will be guided as per the provisions mentioned here under:

1. **VACANCY & PROGRAMME:**

The vacancy is provisional and is subject to change as on the date of Walk-in-Interview/counseling. Vacancies occurring after the date of counseling shall be filled up through fresh advertisement. The detailed vacancy attached in Annexure-II will be available in the website of FMMCH, Balasore (i.e. <https://www.blsmch.nic.in>).

2. **Schedule of Walk-in –Interview :**

Date: 15.04.2025

Reporting Time: 10.30 AM to 11.30 AM

Venue: Office of Dean & Principal, FM MCH, Balasore

3. **Reservation:**

As the Senior Resident/ Tutor posts are tenure posts there shall be no reservation.

4. **Age:** Must be less than 45 years as on the date of joining in the post.

5. Eligibility and Qualifications for Senior Residents:

- i. For the post of Senior Residents (non academic) in Clinical Departments (Speciality) the candidate must possess MD/MS/DNB or any Equivalent Degree in concerned discipline applied for or as prescribed by OMES Rule/NMC in "Minimum Qualifications for Teachers in Medical Institutions Regulations, 2022" notified or amended from time to time in force.
- ii. All Qualifications as on the date of counseling shall be considered.

5.3. Other eligibility conditions:

- 5.3.1. The candidate must be a citizen of India.
- 5.3.2. The candidate must not be continuing or have completed the tenure of three years as Senior Resident in any Govt. Medical College of the State.
- 5.3.3. The candidate whose service as Senior Resident has been terminated by any govt. Medical College in the state for whatsoever reason will not be considered for re-engagement.

6. Eligibility and Qualifications for Tutor:

- i. For the post of Tutors as prescribed by NMC in "Minimum Qualifications for Teachers in Medical Institutions Regulations, 2022" from time to time in force.
- ii. For the post of Tutors in Pre-clinical/para-clinical departments. MBBS is the basic qualification. However, first preference will be given to the candidates having Post Graduates degree in concerned disciplines and candidates with MBBS degree can only be considered if no MD/MS/MDS/DNB candidates are available in any category of the said disciplines.
- iii. If sufficient number of MBBS qualified candidates are not available, the candidates having M.Sc Degree in Medical Anatomy, Medical Physiology, Medical Biochemistry, Medical Pharmacology & Medical Microbiology along with any other additional qualifications as may be prescribed by Medical Council of India shall also be considered in the concerned discipline only. However, MBBS candidates shall be preferred to M.Sc candidates.
- iv. MBBS candidates can apply for Tutor in more than one discipline in pre & para-clinical subjects using separate application form for each discipline.
- v. All Qualifications as on the date of counseling shall be considered.

6.3. Other eligibility conditions:

- 6.3.1. The candidate must be a citizen of India.
- 6.3.2. The candidate must not be continuing or have completed the tenure as Senior Resident/Tutor in any Govt. Medical College of the State.
- 6.3.3. The candidate whose service as Tutor has been terminated by any govt. Medical College in the state for whatsoever reason will not be considered for re-engagement.

7. Procedure for Application:

Candidates shall download the Application Form (i.e Annexure-1) enclosed in this Advertisement from the Official website of FM MCH, Balasore (<https://www.blsmch.nic.in>) and come for the Walk in Interview along with duly filled in Application Form and all requisite documents (in original and its photocopy).

8. Procedure of Interview:

a. The candidate shall have to appear in person before the Convenor, Selection Committee on **15.04.2025 at 10.30 AM. in the Office of Dean & Principal, FM MCH, Balasore** along with the following documents:

1. Application Form – Duly filled in
2. One recent passport size colour photograph signed by the candidate at front to be pasted on the application form.
3. All Original Documents and Self-attested Photocopies of -
 - i. H.S.C. / Equivalent Certificate in support of age;
 - ii. +2 Science / Equivalent Examination Certificate;
 - iii. MBBS/MD/MS/DNB/ Pass Certificate
 - iv. Mark Sheets in support of all the aforesaid examinations
 - v. Chance Certificate of MBBS/MD/MS/DNB.
 - vi. Internship Completion Certificate
 - vii. Valid Certificate of Medical Registration (Both UG & PG)
 - viii. Certificate from competent authority in support of Reservation
 - ix. Service certificate if in-service.
 - x. Valid Photo ID Card issued by Govt. Authority (Passport/ Aadhaar Card/ PAN Card/ Voter ID Card)

b. There will be Document Verification and Interview by the Selection Committee based upon which candidates will be selected. At the time of document verification, physical presence of the candidate is mandatory and no authorization will be entertained.

9. Selection of Candidates :

- i. After completion of Document Verification & Selection Procedure, a Provisional Merit List shall be prepared and notified in the website (www.blsmch.nic.in) on 16.04.2025 for inviting any grievance to the merit.
- i. The grievances from the candidates, if any, will be allowed to be put forth to the Email 'dean.fmmchb@gmail.com' by 17.04.2025.
- ii. The Final Merit List will be notified and Engagement Order will be uploaded in the website after compilation of grievance if any.
- iii. The candidates must report before the head of Office immediately or within 7 days of issue of engagement order.
- iv. In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject may be given a chance.
- v. The final merit list will remain valid for a period of one year or till subsequent advertisement whichever is earlier. Any other related information / changes if required shall be notified by the Convenor, Selection Committee in the official website of FMMCH, Balasore i.e. <https://www.blsmch.nic.in> . All communication shall be made through the website of FMMCH, Balasore (No Postal/ Personal communication will be made).
- vi. The date & timing of publication of provisional & final merit list may be changed depending upon the number of candidates attending walk in interview.

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary /legal action as deemed proper will be initiated against him/her.

10. Selection Process:

1. Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:
 - HSC/Matriculation- 20% of total percentage of marks secured.
 - Intermediate Science- 20% of total percentage of marks secured.
 - MBBS/M.Sc examination- 60% of total percentage of marks secured.
2. One mark will be deducted from total Career Mark for each extra attempt taken to pass the examination.
3. In case of Foreign Medical Graduates (FMGE), the marks secured in the subjects as per the **NMC/MCI** conducted by NBE shall be taken for calculation of merit as above. Where the candidate does not submit such mark sheet, their mark shall be taken as 50%.
4. In case of tie, it will be resolved as follows:
 - i. The candidate securing more mark in MBBS shall be placed in higher rank.
 - ii. In case of further tie, the elderly candidates shall be placed higher in rank to the younger."

11. Terms and Conditions :

The terms and conditions will be followed as per the Resolution No.18582/H dtd.13.08.2020 of Health & F. W. Department, Govt. of Odisha and Govt. Guidelines issued from time to time in force will be followed.
